Manager Kratz reported on the following:

- We have sent out several press releases in the last month regarding positive WNV cases and more Aedes aegypti mosquitoes identified in Palmdale.
 Trustee Manning inquired if the district is notified of human WNV cases. Manager Kratz explained that the district is notified by the health department but there is a lagtime due to strict HIPAA laws in California. Therefore, we continue with business as usual and focus continually on public outreach, surveillance and treatment.
- Brenna spent the day filming today with Zaxis Media Co.. They focused on the technicians duties in the field and general education on the districts functions. We will be posting these videos on social media as well as our website. We will also use these videos for training purposes.
